# **Robert F. Reid Scholarship**

#### INTRODUCTION

This fund was created by Martin Teplitsky to honour Robert F. Reid. Robert F. Reid was born and raised in Stratford, Ontario. After a stint in the RCAF, he entered law school and was called to the bar in 1949. He taught Administrative Law at Osgoode Hall Law School and was assistant secretary to the Law Society of Upper Canada. He practised primarily in the area of Securities Law at Day, Wilson, Thomson Rogers and finally at Reid Perry. He wrote articles on Administrative Law, his earliest published work being found at 1958, 1 Canadian Bar Journal, 57. After his call to the Bench in 1974, Mr. Reid continued to speak and write principally on Administrative Law topics. In his 16 years judicial career, 548 of his judgments were reported most in either the Ontario Reports or the Dominion Law Reports. After his retirement from the bench in 1990, Mr. Reid joined Teplitsky, Colson as counsel. He became the Indian Claims Commission's Legal and Meditation Advisor and mediated numerous land claims. He was also busy as an arbitrator of commercial disputes. Mr. Reid continued to write articles and speak on Administrative Law subjects. His expertise in this area was widely recognized. He predicted long in advance both the trend to deference and the contraction of tests on judicial review to correctness and reasonableness.

#### PURPOSE OF FUND
